## with Rio Tinto (RTIO)

### **Background:**

The RTIO Regional Framework Deed (RFD) is an agreement between RTIO and Pilbara Traditional owners who have 'opted-in' to the Deed. The Banjima People have 'opted in' together with Nyiyaparli, Ngarlawangga, Ngarluma, PKKP, Yindjibarndi, and Yinhawangka.

#### About the committee:

The Regional Implementation Committee (RIC) brings the 'opt-in' groups together formally. The primary function of the RIC is to coordinate the implementation of the RDF and it plays an important role in providing Traditional Owner direction to RTIO on a regional basis.

Banjima committee members engaged in consultations on employment and training, business development and contracting. As a committee member you'll not only actively support these initiatives and making a meaningful contribution to the wider Pilbara community but gain a range of valuable skills in personal development, networking, and collaboration.

### Requirements:

- Committees meet at least twice a year in Perth, with the possibility of additional meetings taking place on-Country.
- Committee member terms will be staggered in either two- or three-year terms to ensure consistency with the handover of knowledge and experience. All future terms will then be three years.
- Committee members will sit either a two-, or three-year term.
- All future terms will be three-years; staggered terms ensure handover of knowledge and experience. The committee must include the following representatives:

1	BNTAC Member	2-year term
2	BNTAC Member	3-year term
3	RTIO representative (nominated by RTIO)	
4	RTIO representative (nominated by RTIO)	
5	RTIO representative (nominated by RTIO)	

# **Eligibility:**

- Members can nominate themselves and sit on more than one committee.
- Members cannot sit for more than two consecutive terms or sit more than two terms in any ten-year period on the RIC.

#### Benefits:

- Travel expenses for meetings, including accommodation, and fuel or flights will be provided.
- Committee members receive a daily sitting fee for their attendance.
