Assistance and support for education

All courses must be studied within Australia, except in the case that members can prove long term residency overseas. In order to qualify for future assistance, students must provide evidence of a minimum pass of school subjects.

Payments will be made direct to suppliers and service providers' banks accounts.

Inclusions

Examples of eligible funding items include the following:

- Fees for courses or relevant formal or informal training;
- Bag, uniforms and shoes;
- Memberships of professional associations;
- Books and stationary (pens, pencils, etc);
- Activities such as field trips;
- Tutors, mentors, coaches and other additional educational assistance;
- Tools of the trade or learning materials as prescribed;

- Computer or iPad (upon proof of requirement);
- Travel such as flights from home address to learning institution and accommodation – it is acknowledged that a lot of courses are held in Perth and beneficiaries from regional areas require this support to attend; and
- Boarding arrangements (upon proof of a formal tenancy agreement).

Exclusions

- Funds cannot be used for mobile phones and costs associated with mobile phones such as phone credit.
- Funds are not to be used for day-to-day travel costs (i.e., bus tickets, taxis, Ubers, etc).
- Gaming computers and accessories are not allowed under the Policy.
- No allocations of funds can be transferred from one beneficiary to another beneficiary.
- No allocations of funds can be rolled over into subsequent financial years.

Beneficiary allowance

Each of the allowances below is per beneficiary, not per child.

- Tertiary/Vet (boarding and rent): up to \$10,000
- Tertiary/Vet (fees and expenses): up to \$10,000
